- That to share knowledge, information and resources and creating opportunities for collaboration in research works.
- 4. That to undertake Students' Exchange Programmes for academic purposes.
- 5. That to offer Faculty Exchange Programmes for a stipulated period for academic purposes.
- 6. That to undertake Students' internships based on academic requirements.
- That to published research book, book chapters, general publication media and other academic journals in collaborative mode between the teachers.
- That to use mutual learning environment as a platform for providing information and communication technology.
- 9. That the students will be made to comply with the policies of both the institutions.
- 10. That to utilise the library resources of the both colleges by students and teachers.
- 11. That to organise extension programmes in collaborative mode for the benefits of the students.
- 12. The MoU will be valid for a period of 3 years renewal.
- 13. Termination: Either party may terminate this MoU by providing written termination notice of its intension to terminate the MoU to the other party.
- 14. Modification: The parties may change or modify the terms of this agreement only by written amendment signed by both the parties.
- 15. Settlement of Disputes: Any disputes concerning interpretation and application of this MoU shall be settled arnicably through consultation or negotiation between the parties.
