MEMORANDUM OF UNDERSTANDING

WHEREAS the First Party, the Principal of Udalguri College and especially the Department of Nepali, Udalguri College, Udalguri represented by the Head of the Department and the Second Party Department of Nepali, Gyanpeeth Degree College situated at Nikashi, Baska, BTR, Assam, represented by its Principal and HoD have entered into this Memorandum of Understanding for undertaking mutually beneficial programmes for quality improvement in the concerned Colleges under the following terms and conditions:





NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:

1. That to organise orientation, lectures, seminars etc for overall development of students and teachers.
2. That to organise Faculty Development programmes in collaborative mode.
3. That to share knowledge, information and reports and creating opportunities for research works.
4. That to undertake students exchange programmes in collaborative mode.
5. That to undertake Faculty exchange programme for a stipulated period for academic purposes.
6. That to undertake student's internship based on academic requirements.
7. That to use mutual learning environment as platform for providing information.
8. That to use library resources of both the colleges by the students and teachers.
9. That to share knowledge, information and resources and creating opportunities for collaboration in research works based on convenience of both the parties.
10. That to publish research books, book chapters, general publication media and academic journals in collaborative mode.
11. That to use mutual learning environment as a platform for providing information and facilitating use of technology.
12. The MoU will be valid for a period of FIVE (05) years before renewal.



13. Termination: Either party may terminate this MoU by providing written termination notice of its intention to terminate the MoU to the other party.
14. Modification: The parties may change or modify the terms of this agreement only by written amendment signed by both the parties.
15. Settlement of dispute: Any dispute concerning interpretation and application of this MoU shall be settled amicably through consultation and negotiation between the parties.
